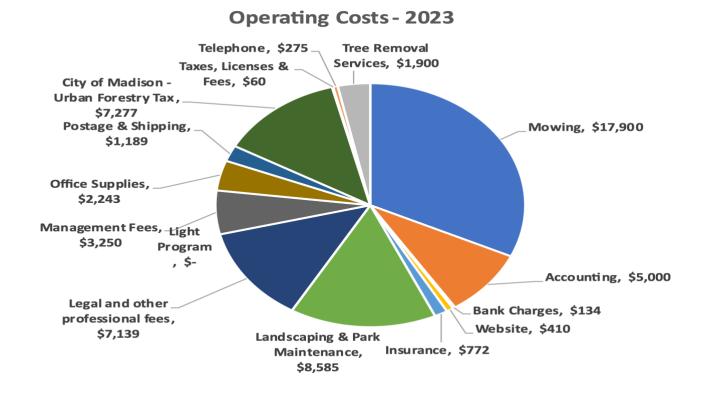
Financial Update:

Notes on the association's 2023 operating costs:

Items where spending exceeded budget by more than \$500:

- Legal fees exceeded budget by \$4,800 due to drafting of proposed amendment changes (\$3,762), and other resident related matters (\$3,377).
- Office expense is for office supplies like printing fees, paper, and envelopes. Supplies exceeded budget by \$1,900 due to additional mailings, most notably the amendment proposals. Printing the amendment proposals was a considerable given the number of pages required. To reduce the cost of this, we printed double sided (this also reduced the cost of postage) and combined it with the annual invoices.
- Postage exceeded budget by \$590 due to additional mailings (one extra newsletter, and the amendment proposals and the required notice for the meeting regarding the proposed amendments). The proposed amendment notice required additional postage beyond a standard stamp, causing this to be more expensive to mail, we mitigated this to some extent by double sided printing and combining it with the annual invoice.
- City of Madison Urban Forestry Tax exceeded budget by \$850. A couple years ago the city agreed to reduce the burden on association and changed the classification of association land in a way that dramatically reduced the taxes imposed, however the charge that they could not remove is based on a rate set by the city which escalates annually. The escalation imposed this year was much higher than anticipated during
- Landscaping and park maintenance appears over budget but this is not including the additional funding (\$4,166) provided by the special assessment (\$2,255) and the prior year carryover (\$1,911). Technically landscaping and park is not over budget. The park fund carryover for 2024 is \$580.
- Snow removal on private courts exceeded budget by \$7,300 due to an active winter beginning of 2023.

Items where spending beat budget by more than \$500:

- Computers and website beat budget by \$590, this was due to this being a non-renewal year for website support.
- Insurance beat budget by \$1,528, this was due to consolidation of association policies which dramatically reduced the premium.
- Tree removal services beat budget by \$5,900, this was due to the lack of storms experienced this summer, storm damage is the primary driver of tree removal costs for the association.
